Subject : Observance of Vigilance Awareness Week, 2019.

1. The Central Vigilance Commission has the mandate under the Central Vigilance Commission Act, 2003 to fight corruption and to ensure integrity in public administration. It is charged with monitoring all vigilance activities under the Central Government and assisting various authorities in Central Government and organizations under it, in planning, executing and reviewing their vigilance work in order to bring about systemic improvement in public administration. In addition, the Commission with its outreach activities also endeavours to create awareness and educate common man especially the youth to wards the perils of activities of corruption and its prevention.

2. Observance of Vigilance Awareness Week every year is part of the multi-pronged approach of the Commission where a key strategy is to encourage all stakeholders to collectively participate in the prevention of and the fight against corruption and to raise public awareness regarding the existence, causes and gravity of and the threat posed by corruption. The Commission has decided that this year the Vigilance Awareness Week would be observed from 28th October to 2nd November, 2019 with the theme "Integrity- A way of life (ईमानदारी एक जीवन शैली)".

3. Corruption can be defined as a dishonest or unethical conduct by a person entrusted with a position of authority, either to obtain benefits to oneself or to some other person. It is a social phenomenon affecting all states in various ways. Corruption is a major cause of political degeneration, democratic erosion, social inequity, the erosion of moral values and much more. It is, therefore, imperative to fight against its pernicious and sinister effects through concerted efforts.

4. The Commission has decided to observe Vigilance Awareness Week from 28th October to 2nd November, 2019 with the theme "Integrity- A way of life (ईमानदारी एक जीवन शैली)".
