Sub: Post Graduate Diploma in Sericulture (Mulberry) course at Central Sericultural Research & Training Institute, Berhampore, West Bengal – Sponsoring of candidates for the session 2018-2019 – regarding.

I am to inform you that the next session of Post Graduate Diploma in Sericulture (Mulberry) (Semester-wise Scheme) is scheduled to commence from 1st July, 2018 at Central Sericultural Research & Training Institute, Central Silk Board, Ministry of Textiles, Govt. of India, Berhampore, West Bengal as detailed below :

Medium of instruction is English

The Course is affiliated to the University of Kalyani, Kalyani, West Bengal.

The Institute has been imparting training in Mulberry Sericulture to the candidates sponsored by various Sericultural State to meet their requirement of trained Technical manpower, for manning the various projects of sericulture development. The details of the course and its prerequisites are as follows :

- 1 **DURATION:** the training will be for a period of 15 [fifteen] Months including 3 months dissertation/project.
- 2 **CAPACITY:** Admission is open for admission is open for 20 candidates [Maximum] from Directorate of Sericulture of different States and another 20 seats for fresh candidates in all 40 seats to be filled up on convertible basis.
- 3 **QUALIFICATION:** Candidates who are possessing B.Sc. degree with Sericulture, Zoology, Botany, Bio-chemistry or Agriculture as electives/optional with a minimum of 45% marks [40% in case of SC and ST] in aggregate may apply in the prescribed form.
- 4 **AGE LIMIT:** maximum of 50 years as on the date of commencement of the course for in service candidates and minimum 21 years for the fresh candidates.
- 5 **COURSE FEE :** The fee for PGDS Course is Rs. 15,000/- only 50% subsidy in course fee is available for candidates sponsored by DoS/DoT and 25% subsidy for candidates sponsored by NGO and No discount on course fee for the candidates seeking direct admission i.e. details fees structure as :

The sponsoring agency has to deposit the prescribed fee in the form of Demand Draft of Nationalized Banks preferably, Central Bank of India/State Bank of India to be drawn in favour of the "Director, CSR&TI, Berhampore, West Bengal" payable at Berhampore[West Bengal] while forwarding the nominations. Other stipulations will be as per University guidelines.

- 6 **ACCOMMODATION & FOOD:** Accommodation will be provided in the hostel against payment of nominal charges of Rs. 50/- [**Rupees Fifty**] only per person/ per day/ per bed. Charges on food are based on actual [dividing system].

As decided by Central Academic Council of Central Silk Board the concerned sponsors have to pay the admissible stipends and other allowances to the candidates as per their eligibility criteria, besides daily allowance during study tour, book allowance etc.

It is requested to depute such candidates after due screening preferable through a written test at this end. However, please ensure that an undertaking from the concerned is taken to the effect that he/she will not claim job opportunity from Central Silk Board or otherwise.

You are also requested to inform the NGOs in your state about the course details and forward their application with the following details for consideration of admission. However, the NGOs / Private entrepreneurs have to bear entire course cost of the candidates sponsored.



This undertaking is to be countersigned and duly attested by the Chief of the NGO. The undertaking in original is to be submitted to this institute at the time of joining the training course.
