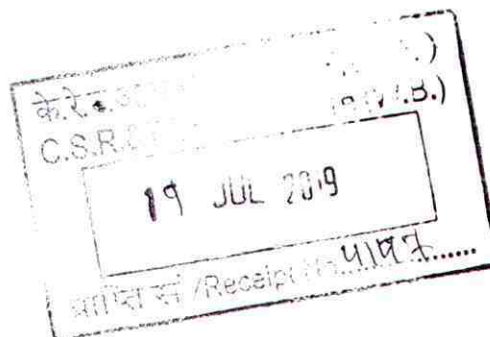

3. These Awards are given by the Hon'ble President of India in Darbar Hall, Rashtrapati Bhavan on week preceding Republic Day every year. Hon'ble Prime Minister of India also felicitates the Awardees. The Awardees of Bal Shakti Puraskar also take part in Republic Day Parade on the 26th of January in Rajpath, New Delhi.

In this regard it is requested that widespread publicity may please be given to these awards within the Ministry and the autonomous/statutory bodies under the Ministry thereby encouraging nomination/recommendation of children, individual and institution through web portal. The last date of receipt of application forms is 31.08.2019.
